NOTICE

### ALL VENDORS MUST BE SELF-CONTAINED! (No utilities will be available at the park)

By acceptance of the application by the Leadership Kerr County (LKC) both the Vendor and the LKC agree to the following:

1. This application is subject to approval by the LKC. LKC assigns locations of booths, but preferences are considered on a first come, first serve basis.
2. A prepaid \$125.00 fee per concession/space is required with the Vendor's application for a 18x10 space or \$155 for a 18x20. If the application is not accepted, the fee will be returned. Food vendors will be required to show proof of insurance. No alcoholic beverage sales allowed (including beer).  
**Carnival/Game vendors must show a) proof of insurance & b) any licensing compliance required**
3. Notification 15 days prior to the event will be required for refund. NO REFUNDS DUE TO WEATHER. Set up shall begin at 2:00 PM on Friday or 8:00 AM on Saturday and vendors shall be ready for business by 10:00 AM on Saturday. All vehicles must be removed by 10:00 AM Saturday. There will be no admittance into the park after 10:00 AM on Saturday. NO EXCEPTIONS. For safety reasons, vendors shall not depart grounds before 6:00 PM on Saturday and shall not endanger invitees or workers when arriving, setting up, breakdown, or departure. All vendors & staff are responsible to comply with any & all instruction from LKC.
4. Vendors shall be responsible for providing proper security and safeguard of all their goods and equipment. The Vendor and/or other invitees of this Festival shall hold the LKC and all promoters of the event harmless for personal injury liability or other losses.
5. No items bearing the name or identification of this Festival or any of its events may be manufactured, sold or distributed without written consent of LKC.
6. This event is organized and operated by Leadership Kerr County and community volunteers.
7. All vendors must sign & return a hold harmless form & must evidence compliance with all local & state ordinances.
8. Each vendor will 'police' their area upon 'tear down' leaving it totally clean & will provide a 50 gal trash receptacle for their space thru the day which they will take away or drop at a designated spot for removal.
9. Vendors & staff will use the same public parking as do all patron
